In a related move, I am obligated to announce the appointment of Mr. Jertzy Fredoham to the position of Senior Economist, Development Advisory Staff for the Eastern Hemisphere. Mr. Fredoham, an alien, has accepted the job after 26 other candidates turned it down. While Mr. Fredoham's track record as a manager speaks for itself, he will retire in three years anyway so long-term damage to the Bank should be minimal.

Mr. Fredoham, who is stateless following his sixth divorce several years ago, joined the Bank via an administrative error in 1978.
